 4) Contracting Company agrees to accept full liability and responsibility for protecting and insuring their employees and agents from injuries and claims while at the facility from setup through move out. Contracting Company further agrees to hold harmless Expositions East Inc. and the facility from all liabilities and workers compensation claims resulting from injuries to their employees, agents or attendees while within the Exhibitor's rental space.
